FIRE SAFETY DURING CONSTRUCTION - ON SITE FIRE PREVENTION PROGRAM DECLARATION

In conformance with the International Fire Code (IFC) Chapter 33, 2018 & 2024 ed., and NFPA Standard 241, 2022 ed.

The owner or owner's authorized agent shall be responsible for the development, implementation and maintenance of an approved, written Site Safety Plan establishing a fire prevention program at the project site applicable throughout all phases of the construction, repair, alteration or demolition work. The owner shall designate a person to be the Site Safety Director. The Site Safety Director shall be responsible for ensuring compliance with the Site Safety Plan. Site Safety Directors shall acquire training specific to their roles and responsibilities. Guidance document available at the GJFD website.

This section shall be completed by the owner or owner's authorized agent with an attached Site Safety Plan for the project. The Site Safety Plan is a required construction document submitted through the GJFD Plan Review portal for the project. The Site Safety Plan shall be submitted prior to issuance of a Building Permit Clearance.
