

DESIGN REQUIREMENTS

Only house numbers painted on the face of curbs are permitted. No street names, logos, designs, graphics or symbols of national, military, religious, sports, flags, college/university, etc., are permitted. Such logos, designs, graphics, and symbols may be registered trademarks and may have copyrights.

Painting house numbers on curbs is only allowed on Local Streets. Curb address painting is not permitted on streets classified as collectors or arterials, as designated on the current version of the Grand Valley Circulation Plan.

6" White back ground with 4" tall black block numbers. Placement shall be on face of curb only.

WHAT YOU NEED TO KNOW

IS CURB ADDRESSING REQUIRED??

NO... The City **does not** require you to have a street number placed on the curb. Whether or not you have your house number painted on the curb is **voluntary** on your part.

The City does require address numbers to be posted on the building. Address numbers on the curb are supplemental only.

The City **DOES NOT** paint addresses on the curb and **DOES NOT** have any association with charitable organizations or businesses that offer this service.

If you paint your address numbers on the curb or have it done by a charitable organization or business, the City shall not be held liable for payment or for the replacement of house numbers on curbs that become painted over, obliterated, removed, damaged, etc., as a result of City facility maintenance, repair, replacement, traffic control, etc.

If you have an active Home Owners Association (HOA), you must find out about any restrictions on curb painting and get approval.

If you are going to paint your address numbers on the curb or have it done be sure to **follow the design requirements**.

SOLICITORS

The **property owner** shall be notified whether the curb painting service being solicited is for payment or "charitable donation. **Charitable donations are not mandatory contributions.**

The solicitor must first obtain the permission of the **property owner** before painting any house number on the curb or refreshing existing house numbers on the curb. If the solicitor paints the curb without the property owner's permission, the property owner is not obligated to provide payment for the curb painting services.

You must obtain permission from the property owner if the residence is a rental.

The worker shall wear a high visibility safety vest when painting house numbers on curbs.

It is your responsibility to find out if there is an active Home Owners Association (HOA). If so, you must contact the association board or property manager to find out about any restrictions on your curb painting project and to get approval. The city is not responsible for violations to the Covenants, Codes & Restrictions (CC&R) arising from the curb painting.

Do not in any way say or imply that you are sponsored by or have any connection to 911 services, the city or county.

Follow the Design Requirements.

FLYER NOTIFICATION REQUIREMENTS

All advertising literature including flyers that he/she proposes to use in soliciting services shall include the following information...

- ◆ **Contact information.** Your name or the name of the business or charitable organization providing the service. A mailing address, a phone number, an e-mail address and a web address if available.
- ◆ A statement of whether the painting of house numbers on curbs is a service for payment or for "charitable donation." Charitable donations **are not** mandatory.
- ◆ The solicitor **is not** a City employee and the City does not employ anyone, at this time, to paint house numbers on the curbs.
- ◆ The City **does not** require you to have a street number placed on the curb. Whether or not you have your house number painted on the curb is **voluntary** on your part.
- ◆ Address numbers painted on the curb are **supplemental only**. The City requires address numbers to be posted on the building.
- ◆ The City shall not be held liable for payment or for the replacement of house numbers on curbs that become painted over, obliterated, removed, damaged, etc., as a result of City facility maintenance, repair, replacement, traffic control, etc.
