1) All fees are assessed per application (eg. A request for a rezone and simple subdivision as part of same project are charged fees for both applications).

2) Failure to obtain a required sign permit/clearance prior to any installation will result in an \$200 penalty fee

3) Failure to obtain a permit or planning clearance prior to construction shall result in an assessment of a 100% penalty fee (eg. Permit fee x 2)
